Fees Schedule

in the version dated 10 March 2023 - valid from 01 January 2024

- **§** 1 Membership fees and funds raised serve solely to enable the society to fulfill its statutory objectives. The wishes of donors and the purposes of project-related donations are taken into account to the extent permitted by the by-laws and the objectives of the society.
- § 2 Membership fees and funds raised must be paid into the society's account:

- § 3 Membership fees are to be paid by members on 31 January of the current financial year or collected by direct debit on this date. Membership fees are due four weeks after joining the society if joining during the year. Applications for an extension of the deadline can be submitted informally to the Board, stating why an extension is needed. A decision regarding the extension will then be made at the next Board meeting.
- § 4 From 1 January 2024, the annual membership fee for society members is set as follows:

Reduced fee for non-profit organisations and institutions a/b 700€

Reduced fee for schools b 300€

§ 5 The annual membership fee does not change if the member joins or leaves the society during the year.

§ 6 In case of doubt, the Board decides to which membership category a member should be allocated. A reduction in the regular membership fee is granted upon application to the Board and by resolution of the Board.

§ 7 The Board decides on the allocation of funds by simple majority. In the event of a tie, the Chairperson or, in their absence, their deputy shall have the casting vote. The planned allocation of funds must be documented in a budget plan.

§ 8 Each institutional member may submit proposals to the Board regarding the utilisation of the society's funds. For this purpose, an informal application stating the objectives and of the project and a projection of the work involved must be submitted to the Board. The Board shall decide on this application promptly at the next Board meeting.

§ 9 All equipment, licences and objects acquired from the society's funds are the property of the society and must be listed in an inventory or inventoried in accordance with the applicable regulations. The inventory is carried out by the management.
